WITH OVER 100 SPECIALIZED DOCKETS IN OPERATION THROUGHOUT OHIO, THE SUPREME COURT OF OHIO, THE OHIO DEPARTMENT OF ALCOHOL AND DRUG ADDICTION SERVICES AND THE OHIO DEPARTMENT OF MENTAL HEALTH HAVE RECOGNIZED THE NEED FOR INTERACTION AMONG THE PROFESSIONALS THAT STAFF THESE COURTS. IN ORDER TO PROVIDE SUCH A FORUM, THE OHIO SPECIALIZED DOCKET PRACTITIONER NETWORK WAS CREATED TO PROVIDE PEER SUPPORT AND TECHNICAL ASSISTANCE TO THESE PROGRAMS. IN ADDITION, THE SUB-NETWORK MEETINGS OFFER OPPORTUNITIES FOR SPECIALIZED DOCKET PROFESSIONALS TO PROVIDE PROGRAM UPDATES, DISCUSS PROGRAM OPERATIONS, AND DISCOVER INNOVATIVE AND EFFECTIVE STRATEGIES EMPLOYED BY OTHER SPECIALIZED DOCKETS. HANDBOOK GUIDES JUDGES IN CREATING MENTAL HEALTH COURT

THE SUPREME COURT OF OHIO TODAY RELEASED A REFERENCE GUIDE FOR JUDGES CONSIDERING STARTING MENTAL HEALTH COURT DOCKETS. THE MENTAL HEALTH DOCKET HANDBOOK OFFERS GUIDANCE FOR JUDGES ON ASSESSING THE NEED FOR THE DOCKET, DETERMINING WHICH TYPE OF DOCKET WORKS BEST, IDENTIFYING PERSONNEL AND RESOURCE ISSUES AND EVALUATING THE PROGRAM. “WE NEED TO FIND NEW WAYS TO CHANGE THE LIVES OF PERSONS WITH MENTAL ILLNESS SO THAT THEY CAN HAVE A CHANCE TO RECOVER AND LIVE A LIFE OF MEANING THAT WE ALL WANT,” SAID SUPREME COURT JUSTICE EVELYN LUNDBERG STRATTON, WHO CHAIRS THE SUPREME COURT’S ADVISORY COMMITTEE ON MENTAL ILLNESS AND THE COURTS. “WE HAVE RECOGNIZED THAT JAILS AND PRISONS HAVE BECOME THE DE FACTO MENTAL HEALTH HOSPITALS OF OUR DAY. THROUGH INITIATIVES SUCH AS MENTAL HEALTH COURTS WE SEEK TO SHATTER THE REVOLVING DOOR THAT HAS DEVELOPED.” [MORE...](#)

OHIO SUPREME COURT HEARS CHALLENGE TO REMOVAL OF CHILDREN

THE OHIO SUPREME COURT YESTERDAY STEPPED INTO A BATTLE BETWEEN LUCAS COUNTY CHILD PROTECTION OFFICIALS AND A FAMILY WITH A DIAGNOSED PEDOPHILE LIVING IN ITS MIDST. BUT WHILE THE FATHER OF TWO YOUNG CHILDREN SERVED PRISON TIME 17 YEARS AGO FOR ABUSING YOUNG BOYS, IT’S NEVER BEEN SHOWN THAT HE HAS HARMED HIS OWN CHILDREN. THAT HAS RAISED THE QUESTION OF WHETHER THE COUNTY OVERSTEPPED ITS AUTHORITY WHEN IT PERMANENTLY REMOVED THE KIDS FROM THE HOME AFTER THE MOTHER REFUSED TO DIVORCE OR SEPARATE FROM THE FATHER. COURT TRIES TO CUT NUMBER OF YOUTHS SENT TO PRISON

FOR THE FOURTH YEAR IN A ROW, FRANKLIN COUNTY WILL TAKE A DEEP CUT IN STATE FUNDS BECAUSE AN INCREASING NUMBER OF THE COUNTY’S YOUTHS ARE SPENDING TIME IN JUVENILE PRISON. THE MORE DAYS FRANKLIN COUNTY TEENS ARE

IN A YOUTH PRISON, THE LESS THE COUNTY RECEIVES TO TREAT JUVENILES OUTSIDE PRISON. [MORE...](#)

TRAINING HELPS POLICE HANDLE THE MENTALLY ILL

OFFICER JIM GILBERT WAS TWO WEEKS REMOVED FROM A 40-HOUR COURSE ON DEALING WITH MENTALLY ILL PEOPLE WHEN HE RESPONDED TO A CALL ABOUT A TEENAGE BOY WANDERING IN TRAFFIC. "I PICKED UP INDICATORS THAT THE KID WAS TRYING TO COMMIT SUICIDE," GILBERT RECALLED. THE COLUMBUS OFFICER WAS ABLE TO SUBDUE THE 15-YEAR-OLD AND HANDCUFF HIM BUT DIDN'T TAKE HIM TO THE JUVENILE DETENTION CENTER. GILBERT TOOK THE BOY TO NETCARE, A MENTAL-HEALTH INTERVENTION SERVICE, AND NO CHARGES WERE FILED. "HIS FAMILY WAS ECSTATIC," SAID GILBERT, NOW A SERGEANT AND THE HEAD OF THE LOCAL POLICE UNION. "BEFORE I HAD THE TRAINING, I WOULD HAVE TAKEN HIM TO JAIL FOR PEDESTRIAN IN THE ROADWAY, INTERFERING WITH OFFICIAL BUSINESS AND RESISTING ARREST." [MORE...](#)

AMBER ALERTS TO BE EXPANDED

FORTY-ONE PEOPLE OLDER THAN 65 IN OHIO HAVE BEEN REPORTED MISSING AND REMAIN UNACCOUNTED FOR, THE STATE EMERGENCY MANAGEMENT AGENCY SAYS. YESTERDAY, THE AGENCY SAID IT IS EXPANDING THE STATE'S AMBER ALERT SYSTEM TO INCLUDE THE ELDERLY AND PEOPLE WITH MENTAL IMPAIRMENTS. OHIO LAUNCHED ITS AMBER ALERT PROGRAM IN 2003, NAMED FOR A 9-YEAR-OLD TEXAS GIRL WHO WAS ABDUCTED AND LATER KILLED IN 1996, THE AMBER ALERT SYSTEM IS SUPPOSED TO QUICKLY NOTIFY THE PUBLIC OF MISSING CHILDREN AND PROVIDE DESCRIPTIONS OF THE CHILDREN AND THEIR CAPTORS WHEN AVAILABLE. JUSTICES LIMIT MENTALLY ILL IN COURT

MENTALLY ILL CRIMINAL DEFENDANTS DON'T HAVE THE SAME CONSTITUTIONAL RIGHTS AS EVERYONE ELSE, THE SUPREME COURT SAID THURSDAY IN CARVING OUT AN EXCEPTION TO THE RIGHT TO REPRESENT YOURSELF. THE JUSTICES SAID MENTALLY ILL DEFENDANTS CAN BE JUDGED COMPETENT TO STAND TRIAL, YET INCAPABLE OF ACTING AS THEIR OWN LAWYER. THE 7-2 DECISION SAID STATES CAN GIVE A TRIAL JUDGE DISCRETION TO FORCE SOMEONE TO ACCEPT AN ATTORNEY TO REPRESENT HIM IF THE JUDGE IS CONCERNED THAT THE TRIAL COULD TURN INTO A FARCE. [MORE...](#)

FREDERICK M. GITTES SAID YESTERDAY HE IS SHOCKED THAT KARNES HAS DEFENDED HIS DEPUTIES FOR SHOOTING A MAN THEY WERE TO TAKE IN FOR MENTAL-HEALTH TREATMENT.

COUNTY TO PAY \$500,000 IN SOMALI'S DEATH

THE FAMILY OF A SOMALI IMMIGRANT, SHOT DEAD BY DEPUTIES WHEN HE PULLED A KNIFE, IS SETTling WITH FRANKLIN COUNTY FOR \$500,000 AND A WRITTEN PROMISE TO BEEF UP CRISIS AND MENTAL-HEALTH TRAINING. "THIS CASE BEGAN WITH A TRAGEDY, NOT CAUSED BY THE DEPUTIES FAILING TO FOLLOW POLICY," U.S. DISTRICT COURT JUDGE EDMUND A. SARGUS JR. SAID. "INSTEAD, TRAINING PROCEDURES HAVE IMPROVED IN CASES INVOLVING THE MENTALLY ILL, AND THIS TRAGEDY HAS BEGOTTEN NEW TRAINING TO GIVE DEPUTIES MORE TOOLS IN DEALING WITH THE MENTALLY ILL." HOSPITAL CALLS COPS AND FEELS THE STING

WHEN THE EMERGENCY ROOM STAFF AT NORTHFIELD CITY HOSPITAL THOUGHT AN OBVIOUSLY DISTURBED PATIENT WAS ABOUT TO TURN VIOLENT, THEY DID WHAT MANY HOSPITALS DO IN THAT SITUATION: THEY CALLED THE POLICE. IN THIS INSTANCE, OFFICERS USED A TASER TO SHOCK THE MAN. THE PATIENT DROPPED TO THE FLOOR, WAS INJECTED WITH MEDICATIONS AND TRANSFERRED TO THE PSYCHIATRIC UNIT AT ANOTHER HOSPITAL, ACCORDING TO AN OFFICIAL REPORT ABOUT THE FEBRUARY INCIDENT. [MORE...](#)

DRUG COURT REHAB

MORE THAN A DECADE AFTER VOTING DOWN A DRUG COURT, CUYAHOGA COUNTY COMMON PLEAS JUDGES FINALLY DID THE RIGHT THING AND APPROVED IT LAST WEEK. THEY DON'T YET KNOW WHERE THE MONEY IS GOING TO COME TO PAY FOR IT. COURT ADMINISTRATOR AND FORMER COMMON PLEAS JUDGE TOM PORKORNY SAYS THE FINANCING COULD COME FROM STATE AND FEDERAL GRANTS. BUT WHAT THE JUDGES DO KNOW - DRAWING FROM THE EXPERIENCE OF CLEVELAND'S DRUG COURT - IS THAT THIS KIND OF PROGRAM WORKS. ALMOST 700 PEOPLE HAVE GRADUATED FROM THE CITY'S DRUG COURT. RISK OF DEATH FROM CONDUCTED ENERGY DEVICES

AN EXPERT PANEL OF MEDICAL PROFESSIONALS FOUND NO DECISIVE EVIDENCE OF A HIGH RISK OF DEATH OR SERIOUS INJURY FROM THE DIRECT EFFECTS OF TASERS AND OTHER CONDUCTED ENERGY DEVICES (CEDs). THE PANEL'S INTERIM REPORT SAID THE RISK OF A DEATH OR SERIOUS INJURY IS LOW WHEN POLICE USE TASERS AGAINST HEALTHY ADULTS. CERTAIN GROUPS OF PEOPLE MAY BE AT MUCH HIGHER RISK OF INJURY OR DEATH FROM TASERS. THESE GROUPS INCLUDE CHILDREN, THE ELDERLY, PREGNANT WOMEN AND PEOPLE WHO HAVE HEART DISEASE. POLICE OFFICERS SHOULD AVOID THE USE OF TASERS AGAINST THESE POPULATIONS UNLESS THE SITUATION EXCLUDES OTHER CHOICES. THE JUSTICE DEPARTMENT IS AWARE OF MORE THAN 300 CASES OF AMERICANS DYING AFTER TASERS WERE USED AGAINST THEM. SOME WERE NORMAL, HEALTHY ADULTS. OTHERS HAD MEDICAL CONDITIONS SUCH AS HEART DISEASE, MENTAL ILLNESS OR CHEMICAL DEPENDENCIES.
